- (2) Represents shares of the Issuer held directly by the Funds. The reporting person is a principal managing director of Thomas H. Lee Advisors, LLC ("Advisors"), which is the General Partner of Thomas H. Lee Partners, L.P., which is the Managing Member of THL Equity Advisors IV, LLC, which is the general partner of the Funds. As a principal managing director of Advisors and a member of THL III, the reporting person may be deemed to beneficially own the shares of the Issuer held indirectly by Advisors and directly by THL III. The reporting person disclaims beneficial ownership of such shares and this report shall not be deemed an admission that the reporting person is the beneficial owner of the securities for the purpose of Section 16 or for any other purpose, except to the extent of his pecuniary interest therein.
