- (2) Represents shares of the Issuer held directly by the Funds. The reporting person is a principal managing director of Thomas H. Lee Advisors, LLC, which is the General Partner of thomas H. Lee Partners, L.P., which is the Managing Member of THL Equity Advisors IV, LLC, which is the general partner of each of the Funds. As a principal managing director of Advisors and a member of THL III, the reporting person may be deemed to beneficially own the shares of the Issuer owned indirectly by Advisors and directly by THL III. The reporting person disclaims beneficial ownership of such shares and this report shall not be deemed and admission that the reporting person is the beneficial owner of the securities for the purpose of Section 16 or for any other puspoe, except to the excten of his pecuniary interest therein.
